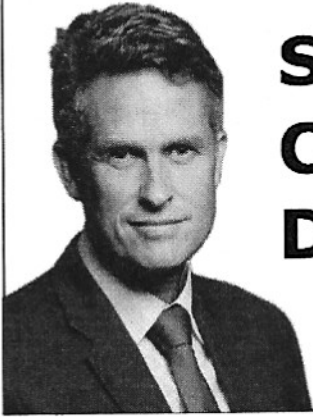
I want to do all that I can to preserve and protect our villages and countryside and thank you for any support that you can offer me in doing so.
